## APPLICATION BY SURVIVING JOINT TENANT\*

**Before submitting documents to the Land Titles Office, please enclose the following:**

- A Statutory Declaration Re Proof of Death completed and signed by the surviving joint tenant or anyone who is acquainted with the facts. The statutory declaration must be sworn before a Commissioner for Oaths who must print his/her name and expiry date or a Notary Public who must affix his/her seal.

### AND

- An original Certificate of Death issued by Alberta Vital Statistics (the original certificate will be returned).

### OR

- The original Funeral Director's Certificate (the original will not be returned, but retained by the Land Titles Office).

### OR

- Certificates by a comparable authority in another jurisdiction.

Notarized copies of official documentation under notary seal can be accepted in lieu of originals. The legal description(s) must be provided.

**NOTE:** If attending the Land Titles Office and swearing the statutory declaration before a Land Titles Commissioner for Oaths, you must produce proper identification (e.g., a valid driver's license, passport or an identification card issued by Alberta Registries).
